

# REGULATION OF "AMUR LEGAL RUN 2024" IN FAVOR OF THE "PODARI ZHIZN" FOUNDATION

#### Place and time of the race

Date and time: June 08, 2024, from 09:00 to 13:00 pm.

Venue: Amur region, Blagoveshchensk city, Park "Druzhbyba".

#### Distance

The program of the Run includes a distance with fixation of results: 1.3 km and 2.6 km; The time limit for the distance is 30 min..

# Run program

09:00-10:30	Opening of the start camp, beginning of the allocation of numbers to participants for the 1.3 km and 2.6 km distances.
10:30	Closing of the procedure for assigning race distance numbers
10:35- 10:45	Race opening ceremony, welcome from organizers, sponsors, etc.
10:45-10:55	Warm-up of participants before the race
11:00-11:05	Gathering in the starting area for the 2.6 km race
11:05	Start for the distance of 2.6 km
11:35	Closing the 2.6 km distance
11:35-11:40	Gathering of participants in the starting area of the 1.3 km race.
11:40	Start for the 1.3 km distance
12:10	Closing of the 1.3 km distance
12:15	Awarding ceremony for winners and runners-up
13:00	Formal closing
10:30-13:00	Musical performances, entertainment, photography

# **Results Registration**

Winners and prize winners of the race will be determined upon arrival at the finish line. A record of the results will be kept by the organizer of the event and will be presented on the official website <a href="http://legal.run">http://legal.run</a>

#### General conditions

A person who receives a race number on the day of the race is considered a participant in the race. Start numbers will be given only to registered persons. All persons who have paid the entry fee on the event website http://legal.run or directly at the time of registration and who have received a race number (if available) are eligible to participate in the race. Start numbers will be issued to registered participants at the event location.

The total number of participants of the race in Blagoveshchensk on the distance is limited and is not more than 80 people.

## Terms of registration

Registration of participants - is carried out on the website http://legal.run in the period from April 10 to June 07, 2024 inclusive.

Assignment of the start number and issuance of the participant's packet is made on the day of the race 08.06.2024.

The recommended amount of the charitable contribution at registration is 500 rubles. Payment of the donation is voluntary and is made by filling out a special payment form on the website of the Gift of Life Foundation at the time of registration at <a href="https://legal.run">https://legal.run</a>

A registered participant is a person who has submitted an application before June 08, 2024.

A person who has been assigned a start number on the day of the race is recognized as a participant of the race.

In case of refusal from registration and/or participation in the race, the fee is non-refundable.

Re-registration for another person is not allowed.

Citizens of foreign countries are advised to have medical insurance covering participation in sports races.

#### Prize fund

Awarding at the distance of 1.3 km for women and 2.6 km for men: 1-3 places.

Winners receive Cups and Diplomas for participation in the charity run.

All finished participants of the race receive medals or diplomas of the participant of the charity run to the e-mail specified in the application form during registration. The organizing committee presents a special Diploma for "The largest corporate team of Amur Legal Run 2024".

## Participants' packages

Before the start: start number badge

On the course: medical assistance at the start/finish point Time recording at 1.3 km and 2.6 km (finish protocol)

After the finish: Diploma (prize-winners on site, other participants by e-mail).

#### Disqualification

The Judging Board (Organizing Committee, Organizer) reserves the right to disqualify any participant if:

- the participant ran under the registered number of another runner;
- the participant shortened the distance;
- the participant used an improvised means of transportation;
- the participant started the race before the official start;
- the competitor started the race after the start area was closed;
- the competitor ran to the finish line after the finish area was closed;
- the competitor did not start the race from the start area;
- the competitor ran without a start number.

#### It is important

These Regulations may be changed or terminated by the Organizers (unfavorable weather conditions, lack of the required number of participants by the day of the race, Refusal of the City Administration to allow a charity run, etc.) unilaterally without prior notice to the participants and without any compensation.
