# LOCATION, TIME, AND DISTANCE OF THE RUN

Date and time: June 8, 2024 from 10:00 to 14:00

Location: St. Petersburg, Primorsky park Pobedyi (Krestovskyi island)

Start / finish point: Central square of the park

The Run program includes the following distances (with timing).

• 2,5 km run;

• 5 km run.

Time limit for the 2,5 km distance – 40 minutes.

Time limit for the 5 km distance - 1 hour.

#### REGISTRATION OF RESULTS

The winners and medalists of the Run distances are determined by the fact of crossing the Finish Line in accordance with the professional standards adopted at sports competitions.

The result of the participant at the distance shall be timed from the time when the participant crosses the starting line.

The results will be available online on the official website of the Run at <a href="http://legal.run">http://legal.run</a> The preliminary results report of the participants will be available in printed form on the information referee point at the day of the Run.

### **GENERAL TERMS AND CONDITIONS**

The Run is open to all those wishing to participate aged from 18 to 70 who have transferred the entry charity fee to the "Gift of Life" foundation. Every person who is given a number on the day of the Run is considered as a Participant of the Run.

The total number of the participants of the Run is limited for both distances to 450 (four hundred and fifty) people.

#### PREPARATION AND RUNNING

Preparation and Running are conducted by the Organising Committee (hereinafter referred to as the "Organising Committee" or the "Organisers"). The Judges are approved by the Organising Committee.

The Organising Committee approves the current Rules of the Run and, where necessary, is authorized to amend them from time to time without prior approval of the Run participants. The duties of the Organising Committee are limited to the following:

- Registration of the participants on the website <a href="http://legal.run">http://legal.run</a>
- Approve of the Run location and distance by the administration of the park and city government
- Arrange refereeing and recording of the results
- Arrange medical assistance during the Run and any other actions contemplated by the "Participant Package" as specified in the Run Rules.

## **REGISTRATION**

Registration of the Participants is available online at <a href="http://legal.run">http://legal.run</a>. The registration starts on 8 April 2024 and finishes on 27 May 2024 or when the limit of 450 (four hundred and fifty) participants of the Run at both distances is reached.

A registration number and the Participant's package are provided on the day of the Run (08.06.2024).

Registration is not available on the day of the Event!

The registration charitable fee (hereinafter referred to as the "fee") is **2,000** (two thousands) roubles for both distances. Payment of the fee by the participants of the run is made by submitting a payment form on the website of the charity "Gift of life" at the moment of

registration at <a href="http://legal.run">http://legal.run</a>

Registered person is considered to have applied online and paid the fee. A person who has been given a starting number on the day of the Run is recognized as a Participant in the Run. If you refuse to register and / or participate in the Run, you shall not be entitled to refund the

contribution. Re-registration to another person is not allowed.

On receipt of a number, the participant must sign the Application, according to which he / she completely removes from the Organisers responsibility for the possible harm to health caused to him / her during the Run. The application form will be provided by the Organisers. Foreign citizens are advised to have a medical insurance covering participation in sports activities.

**AWARDS** 

Awards at a distance of 5 km for men and women:

• Men: 1-3 places;

• Women: 1-3 places.

The winners receive cups, all the finishing runners receive medals.

Awards at a distance of 2,5 km for men and women:

Men: 1-3 places;

Women: 1-3 places.

The winners receive cups, all the finishing runners receive medals.

Traditionally, the Organisers also give a special award for "The largest corporate team", as well as the award for "The most original suit".

# PARTICIPANT'S PACKAGE

#### At the start line:

- branded started pack
- breastplate start number with individual chip
- storage room
- men/women locker room

# During the run:

water, lavatories

- medical assistance at the start / finish
- 2,5 km and 5 km timing (finish record)

### At the finish line:

- memorable medal
- personal result online immediately upon the finish

# **DISQUALIFICATION**

Judges shall disqualify the Participants in the following circumstances:

- the participant ran under the registered number of another runner;
- the participant reduced the distance;
- the participant ran a distance without registration;
- the participant used an improvised means of transportation;
- the participant started the run before the official start;
- the participant started the run after closing of the start zone;
- the competitor ran to the finish after the closing of the finish zone;
- the participant commenced the run not from the start zone;
- the participant ran without a breastplate starting number.
